About the Company

Power Grid Corporation of India Limited (POWERGRID) is a Schedule 'A', 'Maharatna' Public Sector Enterprise of Govt. of India, a listed entity operating under aegis of Ministry of Power incorporated in 1989 and is engaged in bulk transmission of Power through its EHV AC/ HVDC transmission network.

POWERGRID is India's largest Electric Power Transmission Utility and at present, the Inter-Regional power transfer capacity of the National Grid is about 112,250 MW of which about 97,290 MW capacity has been implemented by POWERGRID. POWERGRID has diversified into Telecom business by leveraging its transmission lines, through stringing of optical fibre cable (OPGW) on transmission lines crisscrossing the entire length and breadth of the country. POWERGRID has been providing consultancy services to domestic and International clients with more than 175 domestic clients and global footprints in 23 countries.

Business Operations

POWERGRID offers in-house expertise in the transmission, distribution, and telecom sectors, including engineering, procurement management, operation & maintenance, financing among others. The company has transmission system for CGS, IPPs, UMPPs and Renewable Energy Integration Grid strengthening schemes, high-capacity transmission corridors for IPP Projects and transmission scheme for Ultra Mega Solar Power Parks. The Company has been regularly undertaking assignments in the various emerging business areas with related adjacencies to power like distribution, railway electrification, and new areas like energy efficiency, smart city and smart grid, EV fast-charging infrastructure and has undertaken pilot projects in smart grid in distribution and grid scale battery storage.

Few Notable Highlights of POWERGRID

- As on March, 2022, the Company owns transmission network consisting of about 1,72,437 circuit kilometer (ckm) of transmission lines (mainly 400 kV & above as well as HVDC) and power transformation capacity of about 4,74,457 Mega Volt Amperes (MVA) with 265 sub-stations.
- As on March, 2022, the Company has established Broadband Telecom Network of about 74,109 kms connecting 458 Point of Presence (PoPs) and 780 Point of Interface (PoIs).
- In FY22, POWERGRID has maintained 99.83% system availability with number of tripping per line for the year contained at 0.33 which was lowest in five years.
- For enhancing connectivity with Nepal, POWERGRID has also signed Shareholders'
 Agreement with Nepal Electricity Authority for Development of Indian portion of
 400 kV New Butwal (Nepal) Gorakhpur (India) transmission line in 50:50 JV with
 Nepal Electricity Authority.
- POWERGRID has signed Joint Development Agreement with Africa50, an infrastructure investment platform founded by African Development bank and African states, to take up Investment in Kenya under PPP mode
- POWERGRID emerged as most preferred bidder as "Project Management Consultant" in Moldova (East Europe) for construction of 400 kV S/c TL and associated SS
