Central to its product logistics engine is a precision compound management system, utilizing an acoustic nano-dispenser which manages movements of each chemical, from its initial synthesis to the creation of mother and daughter plates and ultimate supply to the client site. This enables TCGLS to store, distribute and supply samples for all its customer needs. For example, with a single customer, TCGLS moves the material to 60 different sites around the globe. TCGLS uses predictive analytics for inventory management, localize stock to reduce delays, and have backup suppliers and diverse routes to minimize disruptions, ensuring agility and competitiveness.
